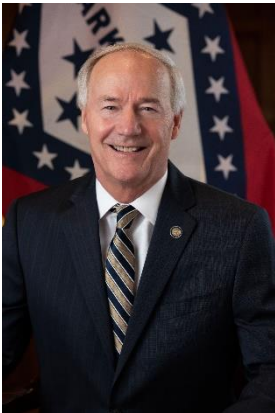

## GOVERNOR ANNOUNCES STATEWIDE FACE COVERING MANDATE

Governor Hutchinson announced that he is signing an Executive Order mandating face coverings statewide effective on **Monday, July 20, 2020**.

[EO 20-43](#) requires every person in Arkansas to wear a face covering over the mouth and nose in all indoor environments where they are exposed to non-household members and distancing of six (6) feet or more cannot be assured, and in all outdoor settings where there is exposure to non-household members, unless there exists ample space of six (6) feet or more to practice physical distancing.

There are several exemptions, and the order does provide for a violation of the directive to be a misdemeanor offense punishable by a fine.

This Executive Order will impact your businesses as all aspects of a dealership likely cannot assure a consistent distancing of six (6) feet.
