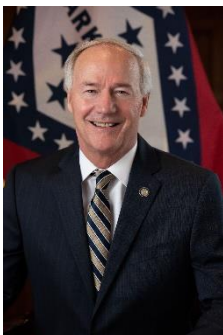
REMINDER: COVID RELIEF PACKAGE SUMMARY

NADA prepared a [summary](#) of the key provisions of interest to dealers and dealership employees of the recent COVID Relief Package recently approved by Congress and signed by the President.

The stimulus legislation clarifies that expenses paid for using Paycheck Protection Program (PPP) loan proceeds are deductible even when the loan is forgiven. NADA had strongly urged Congress to restore the full deductibility of such expenses for all PPP recipients before the end of the year. Additionally, the legislation extends some benefits available under the Families First Coronavirus Response Act (FFCRA).

GOVERNOR EXTENDS PUBLIC HEALTH EMERGENCY ORDER



On, December 29, 2020, Governor Hutchinson issued [Executive Order 20-53](#) extending the previous order of a public health emergency another sixty (60) days.

EO 20-53 continues the previous Department of Health Directive on Business Limitations as well as Guidance for Retail Businesses which are
